WHAT IS CULTURAL RESOURCE MANAGEMENT?

When federal or state funds/lands will be impacted by a project's construction (or undertaking), cultural resource investigations are often required. Federal, state, and local compliance laws, such as Section 106 of the National Historic Preservation Act (NHPA), may require a pedestrian survey to inventory, assess, and map archaeological sites, buildings, structures, and objects to determine if they are eligible for inclusion in the National Register of Historic Places (NRHP).

Cultural resources may be eligible for the NRHP because of their association with a significant event, important people, architectural or artistic significance, or important information potential.

Sites within a project area are recommended as eligible/not eligible for inclusion in the NRHP based on certain criteria, and the State Historic Preservation Officer (SHPO) and other agencies, as appropriate, provide concurrence on Zia's recommendations.

If eligible cultural resources are located within a project area, efforts are then made to either avoid or reduce impacts to the location through data recovery (or mitigation) efforts. Data recovery is generally a destructive process, in which a site is often excavated to exhaust its research potential.
